INFORMATION AND INSTRUCTIONS FOR BIDDERS FOR E-TENDERING FORMING PART OF BID DOCUMENT AND TO BE POSTED ON WEBSITE

1. The intending bidder must read the terms and conditions carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
2. Information and Instructions for bidders posted on website shall form part of bid document.
3. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.gbpssi.in, www.eprocure.gov.in but online tender will be uploaded on www.eprocure.gov.in
4. But the online bid can only be submitted after depositing of original EMD in the office of Administrative Officer of G.B.Pant Social Science Institute, Prayagraj within the period of bid submission and uploading the mandatory scanned documents such as Demand Draft or Pay order or Banker's Cheque or Deposit at call Receipt or Fixed Deposit Receipts and Bank Guarantee of any Scheduled Bank towards EMD in favor of Administrative officer Govind Ballabh Pant Social Science Institute, Prayagraj as mentioned in NIT, receipt for deposition of original EMD to office of the Administrative officer Govind Ballabh Pant Social Science Institute, Prayagraj and other documents as specified.
5. Those contractors not registered on the website mentioned above, are required to get registered beforehand.
6. The intending bidder must have valid class-III digital signature to submit the bid.
7. Contractor can upload documents in the form of **JPG** format and **PDF** format.
8. Contractor must ensure to quote rate of each item.

E-Tendering

1. Item rate bids are invited from approved and eligible contractors (registered with Allahabad University) for the work of-“Repair and Renovation work of Kitchen, at the Guest House, G.B. Pant Social Science Institute, Prayagraj”

The enlistment of the contractors should be valid on the last date of submission of bids.

In case the last date of submission of bid is extended, the enlistment of contractor should be valid on the original date of submission of bids.

- 1.1 The work is estimated to cost ₹ 5,52,465/-. This estimate, however, is given merely as a rough guide.
2. Agreement shall be drawn with the successful bidders on prescribed Form. Bidders shall quote his rates as per various terms and conditions of the said form which will form part of the agreement.
3. The time allowed for completion of the work is 15 (Fifteen) days from the date of issue of the Letter of Acceptance (LOA) or from the date of handing over of the site to the contractor, whichever is earlier.
4. The site for the work is available.
5. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen on website www.gbpssi.in, www.eprocure.gov.in
6. After submission of the online bid the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
7. While submitting the revised bid, contractor can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.
8. Earnest Money in the form of Treasury Challan or Demand Draft or Pay order or Banker's Cheque or Deposit at Call Receipt or Fixed Deposit Receipt (drawn in favor of Administrative Officer, Govind Ballabh Pant Social Science Institute, Prayagraj) shall be scanned and uploaded to the e-Tendering website within the period of bid submission. The original EMD should be deposited in the Office of Administrative Officer, Govind Ballabh Pant Social Science Institute, Prayagraj within the period of bid submission. The Office of the Administrative Officer, Govind Ballabh Pant Social Science Institute, Prayagraj shall issue a receipt of deposition of earnest money deposit to the bidder in a prescribed format (enclosed) uploaded by the tender inviting authority.

This receipt shall also be uploaded to the e-tendering website by the intending bidder up to the specified bid submission date and time.

Documents as specified in the bid document shall be scanned and uploaded to the e-Tendering website within the period of bid submission. Further, the certified copies of all the scanned and uploaded documents, if required, shall be submitted by the lowest bidder physically in the Office of the Administrative Officer, G.B. Pant Social Science Institute, Prayagraj, within 3 (three) days of opening of the tender.

Online bid documents submitted by intending bidders shall be opened only of those bidders, whose original EMD deposited with Office of the Administrative Officer, Govind Ballabh Pant Social Science Institute, Prayagraj.

The bid submitted shall be opened at 10:00AM on 23.03.2026

9. The bid submitted shall become invalid if:
 - (i) The bidder is found ineligible.
 - (ii) The bidder does not deposit original EMD Office of the Administrative Officer, Govind Ballabh Pant Social Science Institute, Prayagraj
 - (iii) The bidder does not upload all the documents (including GSTN) as stipulated in the bid document including the copy of receipt for deposition of original EMD.
 - (iv) If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted **physically by the bidder** in the office of bid opening authority.
 - (v) If a tenderer quotes nil rates against each item in item rate tender or does not quote any percentage above/below on the total amount of the tender or any section/sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.
10. The contractor whose bid is accepted will be required to furnish **performance guarantee of 10% (Ten Percent)** of the bid amount within 03 (three) days from the date issue of LoA. This guarantee shall be in the form of Fixed Deposit Receipts drawn in favor of Administrative Officer, Govind Ballabh Pant Social Science Institute, Prayagraj. In case the contractor fails to deposit the said performance guarantee within the period including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor. The earnest money deposited along with bid shall be returned after receiving the aforesaid performance guarantee.
11. Description of the work is as follows: -"Repair and Renovation work of Kitchen, at the Guest House, G.B. Pant Social Science Institute, Prayagraj."Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A bidders shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidders shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a bid by a bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the local conditions and other factors having a bearing on the execution of the work.
12. The competent authority on behalf of the Director, Govind Ballabh Pant Social Science Institute, Prayagraj does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.

13. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for rejection.
14. The competent authority on behalf of Director, Govind Ballabh Pant Social Science Institute, Prayagraj reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
15. The contractor shall not be permitted to bid for works in the Institute if his near relative is posted as an employee in any capacity in the Institute. He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any faculty/officer/staff in Govind Ballabh Pant Social Science Institute. Any breach of this condition by the contractor the Institute will recommend CPWD/University of Allahabad to remove the firm from the approved list of contractors of CPWD/University of Allahabad .
16. No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of one year after his retirement from Government service, without the prior permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the bid or engagement in the contractor's service.
17. **The bid for the works shall remain open for acceptance for a period of 30 days.** If any bidders withdraws his bid before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to the department, then the Institute shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the bidders shall not be allowed to participate in the rebidding process of the work.
18. This notice inviting Bid shall form a part of the contract document. The successful bidders/contractor, on acceptance of his bid by the Accepting Authority shall within 15 days from the stipulated date of start of the work, sign the contract consisting of:-
 - (a) The Notice Inviting Bid, all the documents including additional conditions, specifications and drawings, if any, forming part of the bid as uploaded at the time of invitation of bid and the rates quoted online at the time of submission of bid and acceptance thereof together with any correspondence leading thereto.

 - 19.1.1 The bidders must associate himself, with agencies of the appropriate class eligible to bid for each of the minor component individually.
 - 19.1.2 The eligible bidders shall quote rates for all items of major component as well as for all items of minor components of work.
 - 19.1.3 Final bill of whole work shall be finalized and recommendation for payment will be made by the Institute J.E. in charge of minor component(s) will prepare and forward the bills to the Administrative Officer Office G.B. Pant Social Science Institute, Prayagraj.
 - 19.1.4 In case of any dispute arising out of any content the decision of the Director, Govind Ballabh Pant Social Science Institute, Prayagraj will be final & binding upon both the parties.
 - 19.1.1 All disputes are subject to Hon'ble High Court of Judicature of Allahabad, Prayagraj.
